3. ผลการดำเนินงานของกองทุนที่การเปรียบเทียบแบ่งตามประเภทกองทุนรวมภายใต้ข้อกำหนดของสมาคมบริษัทจัดการลงทุน โดยกองทุนที่จะถูกเปรียบเทียบผลการดำเนินงานในแต่ละช่วงเวลากับกองทุนประเภทเดียวกันในระดับเปอร์เซ็นต์ไทล์ (Percentiles) ต่างๆ โดยแบ่งออกเป็น
 - 5th Percentile แสดงผลการดำเนินงานของกองทุนอันดับที่5 เปอร์เซ็นต์ไทล์ (Top 5% performance)
 - 25th Percentile แสดงผลการดำเนินงานของกองทุนอันดับที่25 เปอร์เซ็นต์ไทล์ (Top 25% performance)
 - 50th Percentile แสดงผลการดำเนินงานของกองทุนอันดับที่50 เปอร์เซ็นต์ไทล์ (Median performance)
 - 75th Percentile แสดงผลการดำเนินงานของกองทุนอันดับที่75 เปอร์เซ็นต์ไทล์ (Bottom 25% performance)
 - 95th Percentile แสดงผลการดำเนินงานของกองทุนอันดับที่95 เปอร์เซ็นต์ไทล์ (Bottom 5% performance)
4. ผลตอบแทนที่มีอายุเกินหนึ่งปีนั้นมีการแสดงเป็นผลตอบแทนต่อปี

เมื่อผู้ลงทุนทราบผลตอบแทนของกองทุนที่ลงทุน สามารถนำไปเปรียบเทียบกับเปอร์เซ็นต์ไทล์ตามตาราง จะทราบว่ากองทุนที่ลงทุนนั้นอยู่ในช่วงที่เท่าใดของประเภทกองทุนรวมนั้น
