20th June 2019 Lectures

For the first class on June 20th, at the morning session, the professor had mentioned about the details of course outlines and the details about the field trips. Then, we got to know about the Cold War details in SEA, for example, the 1st war, which is called "Indochina war", following with the 2nd Indochina war, which occurred during 1961-1975 and the 3rd one occurred in 1978-1991. During this time, CLMV countries had introduced the gradual economic reforms. Next, we talked about Bangkok Declaration in 1967, which had the goals to promote regional cooperation and ensure stability. The next topic was about the phases of Economic Integration in SEA, which was about the information of the early years, the Pre-AFTA, and the AFTA period. We got to see the graphical results of ASEAN trade shares, which were fluctuated through out year 1990-2012 and FDIs through out 1997(After Tom Yom Kung Crisis)-2013 among ASEAN countries. The next one, we talked about AEC, which were contained information about its FDIs and the goal of closing the development gaps. We also got to

learn about Extra-ASEAN FTA. For the rest of the afternoon, we had discussed about the factors through the graphical data about growth & ages, FDIS, ASEAN shares, Trades of goods, partners for exportation, opportunities and challenges, and communication, etc. For this first class, we have obtained a lot of overall information that we need to acknowledge about ASEAN, AEC, and CLMV.
