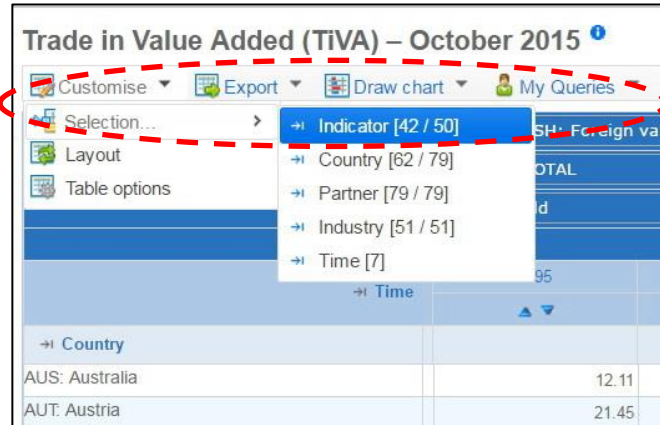

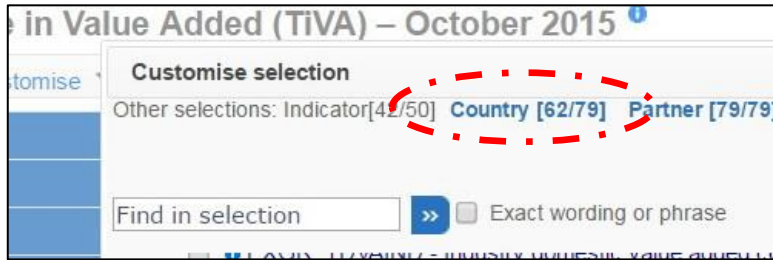
Step 2

→ “Selection” → “Indicator”.

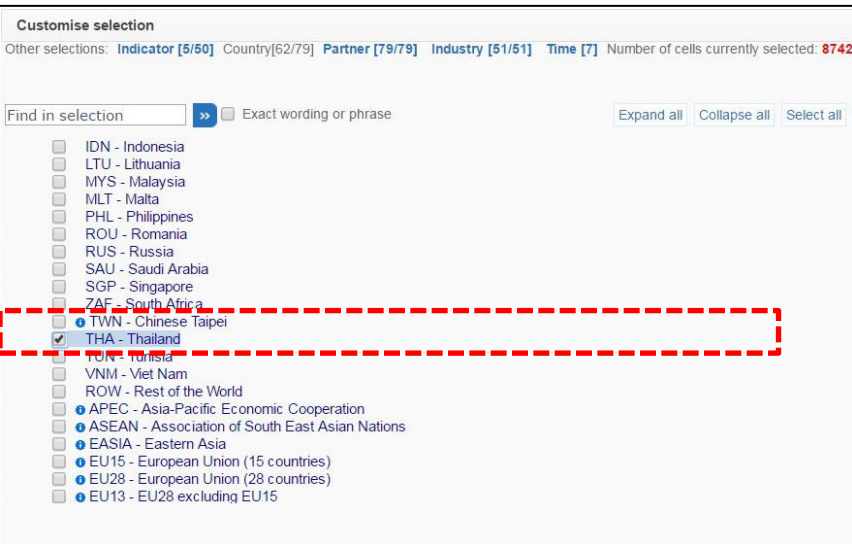


2.2) On the list of key indicators, select these 3 key indicators.

2.3) On the top menu, select “Country”.



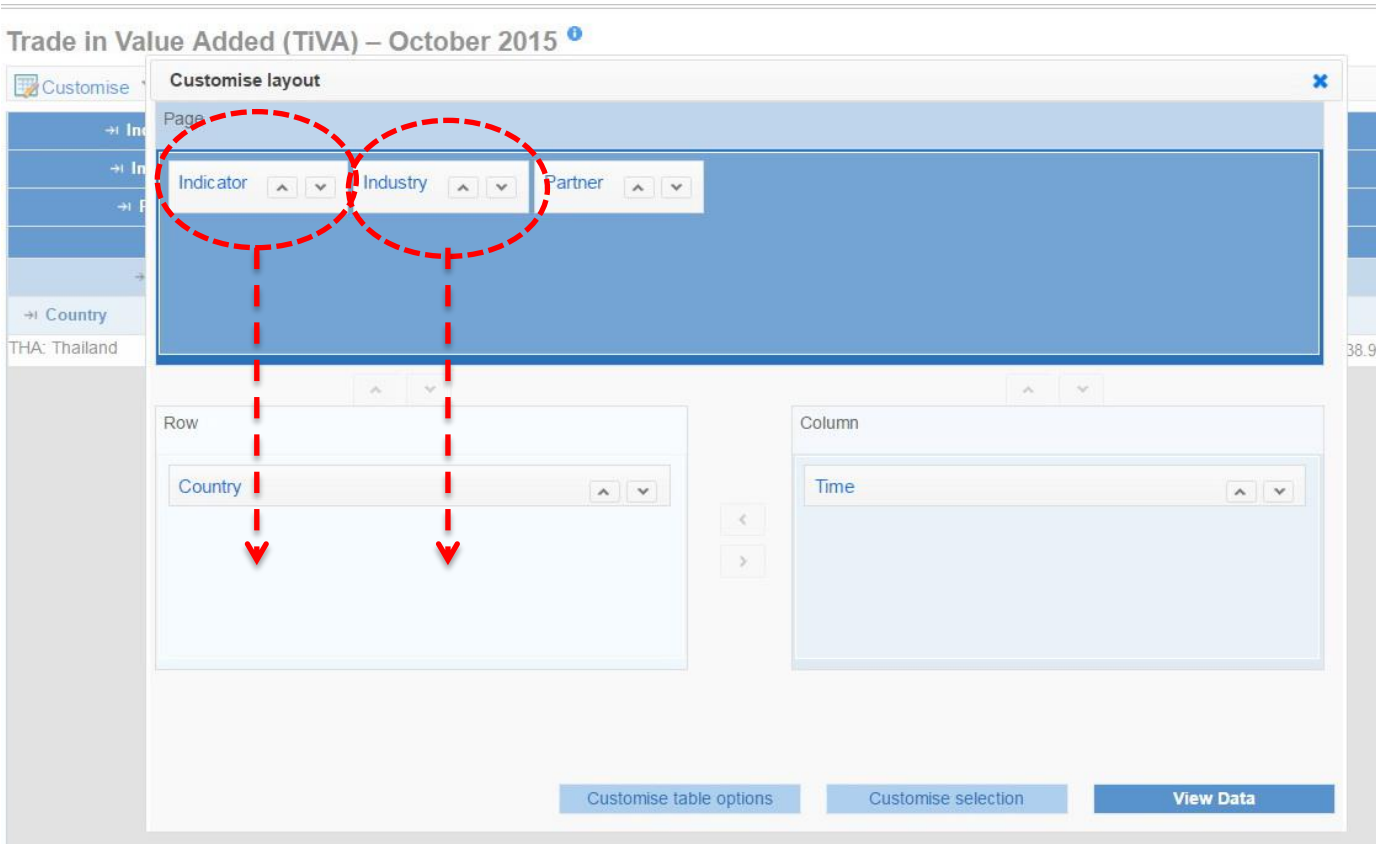
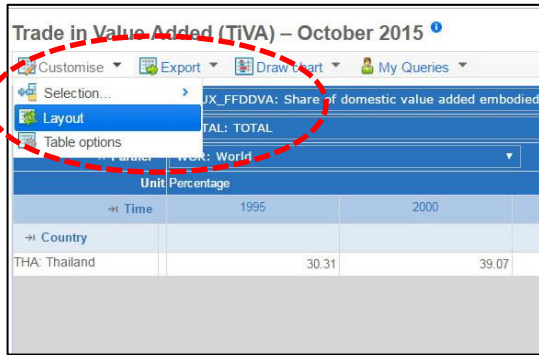
2.4) On the list of countries, select “Thailand”.


