

To begin, I am going to talk about what is meant and the root of political economy and development. Now a day in Thailand, we have saw a lot of news about the demonstration from Thai collegian that do not want to have the communism system and want to reduce a role of the monarchy in Thailand. They illustrate their thought, why they do what they are doing right now, show the darkness side of the government, and reason that they should quit their job that they are doing right now. From the news, there are a lots of people who attend to this demonstration, not only students and collegians who attend, but also a lot of people in different generation such as elderly, actors, people in the middle age, and etc. The demonstration in this time start around the afternoon of the day at Bangkok's Democracy Monument. In that day, it had several of activists and comedians spoke on the stage to show the attitude of demonstration in this time and making joke for people around the Bangkok's Democracy Monument. This demonstration construct the ten main demand, for the first one is to repeal Article 6 of the Constitution that no one can sue the king and add provisions for the House of Representatives to consider the king's offenses as previously provided in the Constitution of the People's Committee, the second is to repeal Section 112 of the Criminal Code and allow people to exercise their freedom to express their views on the monarchy. And amnesty those who have been prosecuted for criticizing the monarchy, the third is to abolish the Crown Property Regulation Act, 2018 and divide it into the crown property under the control of the Ministry of Finance. And his belongings that are clearly private of the king, the fourth is to reduce the budget allocated to the monarchy. In accordance with the national economy. The fifth is to cancel government agencies in the King Agencies with clear duties,

such as the Royal Highness Security command to move to under another agency and non-essential entities such as the Privy Council. The sixth is to cancel all donations and accept donations by Sudeet Royal Charity to direct the monarchy finances to be totally under review. The seventh is to abolish royal authority to express political views in public places. The eighth is to cancel any publicity and education that extolls the monarchy at all alone. The ninth is to investigate the truth about the killing of people who criticize or have any connection with the monarchy. The tenth, it is forbidden to sign a royal sign to endorse any other coup. And these are all ten demand that the protesters request to the government. Before this demonstration was held, there was another event that has the same purpose with this demonstration in Thammasat University's Rangsit Campus in Pathum Thani which also has a main demand too. The main demand that the activists request only has three issues, for the first issue is the government must "stop threatening the people" for exercising democratic rights and freedoms. The second is the government has to "draft a new constitution" that comes from the will of the people. For the real benefit of the public. And for the last one is the government had to "dissolve parliament" so that people could once again show their intention to elect their representatives. These three demand concepts are based on two principles that there must be no coup and the formation of a national government. The next paragraph, I will mention the good and bad effect that the demonstration causes to the society.

For this paragraph, we will see how good and bad things that created by the demonstration affect to the society. Let's start with the bad things, we can easily see it from the above situation that I mentioned about the demonstration at Bangkok's Democracy Monument. In that day, the polices have to block the road way for the leaders of the protest and people who attend to join the event so this action making people who have to use this road have to change the way to avoid the protesters it cause a terrible thing to people who do not related to this event. The roads that around the Bangkok's Democracy Monument have to close and this caused a lot of traffic jam because people that usually use this road have to change their way to another road. This is not looking good for the demonstration so people that want to have this event happened should find the new way to organize a protest. And another one important thing is if there was some severity happened, it may cause a crossfire to other people who do not even relate to this action. If this happens, what the protesters could do?
