She also provides us essential topics about the course which are divided in to two parts which are ASEAN Versus AEC and ASEAN Economy. In this lecture there are some topic that is familiar and some of the topic is new to me. I am going to talk about the fun ASEAN quiz first following by ASEAN Versus AEC and ASEAN Economy. /

The propose of ASEAN quiz is to let us know about the idea and position of countries in the sense of income per capita, GDP and population. The lecturer tries to sum up ASEAN in an easy way by make us guess about some fact about countries in ASEAN. There is some fact that I have never heard about before as Brunei have the lowest number of population and Indonesia have the highest population. In addition, Cambodia, Laos and Myanmar ranked in the first three highest growth in ASEAN in 2017 with the reason that those country use to be poor and when they start to develop, they grow faster than those countries that are developing. There is also some specific word that I am not familiar with such as Doi Moi. I first thought Doi Moi is a famous coffee in Vietnam but it becomes a policy reforms in Vietnam as there was a Vietnam war and a communist party. They want to reform economy to be more market base so the policy reform is called Doi Moi.

Next, we talk about ASEAN and AEC. Firstly, the different between ASEAN and AEC is that ASEAN is Association of South East Asian Nations and AEC is AEAN Economics Community. We can say that ASEAN is the group of country that trying to form because of a Domino effect from Russia. If one country in this area become communist, neighboring

countries will become communist right after. Therefore, the starting point of ASEAN involved in political issue. Afterwards, it becomes an Economic integration in South East Asia which is ASEAN Economic Community (AEC). From the beginning to present day, there are circumstances and event that involves with the member states from cold war, Pre-AFTA, AFTA to AEC. We can see that ASEAN founded for many years and we also know that there are AEC so the integration of the south east Asian country would mean something.

We will talk about ASEAN economy from now on. There are ten members in ASEAN and if we considered ASEAN as a country, it is a massive economic growth as it has rapid growth and stable. ASEAN's GDP ranked the seventh and expected to be the third in 2030. Overall economic condition of ASEAN is stable because the real GDP growth is ranked the third and the volatility of the GDP growth is low meaning that it is minimal fluctuation between year. In addition, the inflation rate of ASEAN is doing fine in 2013 as it is 2.8% which is below 3 %. Moreover, the ASEAN's population is the third large in the world in 2014. We get benefit from that because we have labor supplied and over half of the population is under 30 years old. ASEAN major trade partner is also members we can call it as intra-trade. We obtained AFTA (ASEAN Free Trade Area) in order to reduce tariff within ASEAN. However, Foreign direct investment from Extra-ASEAN is more than intra-ASEAN. It would be because of the lower wage rate and number of populations.

Based on information we obtained earlier, we can see that ASEAN can be a strong Economic group if we obtain better technology because we have advantage of a low wage rate. ✓ In addition, if number of skilled workers rapidly increase, foreign direct investment from Extra-ASEAN would also increase and it can benefit countries in ASEAN for example Cambodia.
