 - Why might this elasticity depend on the time horizon?

7. Suppose that your demand schedule for pizza is as follows:

Price	Quantity Demanded (income = \$20,000)	Quantity Demanded (income = \$24,000)
\$8	40 pizzas	50 pizzas
10	32	45
12	24	30
14	16	20
16	8	12

- Use the midpoint method to calculate your price elasticity of demand as the price of pizza increases from \$8 to \$10 if (i) your income is \$20,000 and (ii) your income is \$24,000.
- Calculate your income elasticity of demand as your income increases from \$20,000 to \$24,000 if (i) the price is \$12 and (ii) the price is \$16.

3a)

short run

$$\eta_D = \frac{\Delta Q}{\frac{Q_1 + Q_2}{2}} \cdot \frac{P_1 + P_2}{2}$$

$$0.2 = \frac{\Delta Q}{\frac{2.2 - 1.8}{2}} \cdot \frac{2.2 + 1.8}{2}$$

$$0.2 = \frac{\Delta Q}{0.4} \cdot \frac{4}{2}$$

$$0.2 = \Delta Q$$

Long run

$$\eta_D = \frac{\Delta Q}{\frac{Q_1 + Q_2}{2}} \cdot \frac{P_1 + P_2}{2}$$

$$0.7 = \frac{\Delta Q}{\frac{2.2 - 1.8}{2}} \cdot \frac{2.2 + 1.8}{2}$$

$$0.7 = \frac{\Delta Q}{0.4} \cdot \frac{4}{2}$$

$$0.7 = \Delta Q$$

In short run when the oil price rise people can not adapt to this change good enough. Price elastic demand show that 0.04 is very in elastic but in long run people can adapt to this change

$$(7a) \text{ (i) income } 20,000 \\ \frac{32-40/36}{10-8/9} = \frac{-8/36}{2/9} = \frac{-0.22}{0.22} = -1 = 1 \text{ unit elastic}$$

$$(ii) \text{ income } 24,000 \\ \frac{45-50/48}{10-8/9} = \frac{-5/48}{2/9} = \frac{0.104}{0.222} = 0.47 = \text{in elastic}$$
