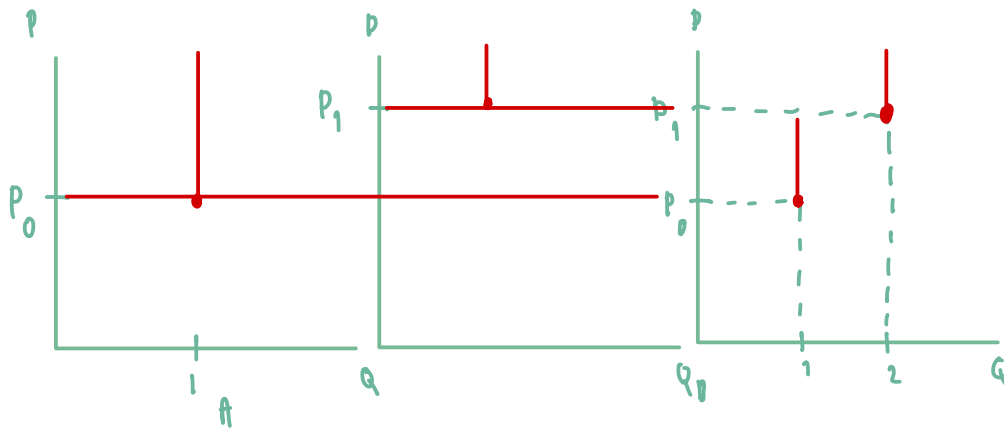


HW 3 Due Thursday, February 11, 2021
